

# Resolution of the Board of Directors of Winn Ridge Homeowners Association New Rule Adoption

WHEREAS, the Board of Directors has reviewed and trash receptacle screening for approval by the Board; and

WHEREAS, the Board deems it appropriate and in the best interest of Winn Ridge Homeowners Association Inc., to adopt and/or supplement current language in the Covenants, Conditions and Restrictions (the "CC&R's"), which language has been presented to the Board as being incomplete and/or inconsistent with the Community-Wide Standard desired of the Board and set forth by the Declarant as described in Article I, Section (i).

**NOW, THEREFORE, BE IT: RESOLVED**, that the Board adopts a supplemental policy regarding Uses Specifically Prohibited located in Article II, Section 2.5 (e), regarding trash can screening as follows:

• Each Lot Owner shall make or cause to be made appropriate arrangements with the City for collection and removal of garbage and trash on a regular basis. Each and every Owner shall observe and comply with any and all regulations or requirements promulgated by the City and/or the Association in connection with the storage and removal of trash and garbage. An Owner may place trash receptacles on the street curb or access easement only on those days designated by the City as trash collection days and/or from dusk the night before until dusk the same day of the trash pickup. On all other days, an Owner must keep all trash, garbage and other waste material hidden from public view. Bulk trash or any other bulky materials may only be placed on the street curb on or the evening before bulk trash pickup day. Owners may submit an application for review for a trash pad on the side of the home.

BE IT FURTHER RESOLVED, the Board of Directors, by at least a majority vote, on this 23<sup>rd</sup> day of September, 2021, do approve and adopt the supplemental rules which are to be become effective immediately after notice is served by written communication to Class A Members. This Resolution may be recorded with the Denton County Clerks notwithstanding, the supplemental rules set forth herein do not require this Resolution to be recorded to be enforceable. Furthermore, the Board shall ratify this action on record at the next regularly scheduled meeting of the Board of Directors.

By our signature below, at least a majority of the Board of Directors of the Winn Ridge Homeowners Association Inc., do hereby consent to the adoption of this Resolution and the policies or rules herein stated above. This document may be executed in multiple counterparts and is enforceable three days from the date notice is deposited with the U.S. Postal Service for delivery to Class A Members.
